**Checklist for Fully Vaccinated Travellers** 

### Instructions before use:

This checklist is for all modes of arrival to Singapore via air, land or sea.

This travel checklist is for **all travellers, including Singapore Citizens or Permanent Residents**, who are:

- Fully vaccinated with WHO EUL COVID-19 vaccines\*; OR
- Aged 12 and below (i.e. born in or after 2010) and not fully vaccinated

If you do not meet the above criteria, you can refer to the <u>checklist for travellers who are non-fully vaccinated</u>. Travellers transiting in Singapore to another destination without clearing immigration should refer to the <u>"Transiting through Singapore"</u> page for information.

\*To be considered fully vaccinated, travellers must have taken at least one dose of Janssen/J&J, or at least doses of AstraZeneca, Covaxin, Moderna/Spikevax, Covishield, Novavax, Pfizer/BioNTech/COMIRNATY, Sinovac or Sinopharm. Mixtures and boosters of these WHO EUL vaccines, and recovery from COVID-19 wit vaccination, are also acceptable. Travellers are advised to follow all the steps in the checklist below to ensure that their journey to Singapore is smooth and that they will be accorded the measures for vaccinated travellers. Details can be found in the respective steps below. Please note that fully vaccinated travellers and travellers aged 12 and below **do not need to take a predeparture test before departing for Singapore**.

- **Step 1.** Ensure COVID-19 vaccination documentation is in order
- **Step 2.** Obtain entry approvals and additional travel documentation if needed
- **Step 3.** Fill SG Arrival Card up to 3 days before arrival
- **Step 4.** Install TraceTogether app
- **Step 5.** <u>Immigration clearance in Singapore</u>
- **Step 6.** Comply with local health protocols

☐ Step 1: Ensure COVID-19 Vaccination Documentation is in Order

☐ Step 2: Obtain additional documentation/approvals for entry if needed	
Prepare the travel documents below, if required, and visitors should ensure that thei passport is <b>valid for at least 6 months</b> . Entries for Long Term Pass holders and visitors can be denied if they do not produce required documents during pre-boardin or immigration clearance.

☐ Step 3: Fill SG Arrival Card up to 3 days before arrival	

The SG arrival card (SGAC) is a simple and free arrival declaration of your travel and health details. Defer your travels if you have experienced the onset of any COVID-19 symptoms in the last 7 days before departure. This may include fever, cough, runny nose, sore throat, loss of taste or smell.

within 3 days before your arrival in Complete your <u>SG Arrival Card (SGAC)</u> Singapore, if you are:

- A Singapore Citizen, Permanent Resident or Long Term Pass Holder arriving via air or sea – SGAC is not required for those arriving by land
- A non-resident (i.e. do not hold any Singapore-issued pass, citizenship or permanent residency), or In-Principle Approval Pass Holder entering **Singapore**. This also applies to travellers entering Singapore daily (e.g. If you

are entering Singapore on 1, 2 and 3 March, three separate SGAC submissions must be made).

Upon the completion of your SGAC, you will receive an email acknowledgement which you can present for smoother pre-boarding and immigration checks.

## ☐ Step 4: Install TraceTogether App

If you are a visitor and do not already have the <u>TraceTogether contact tracing mobile application</u>, install it using <u>this guide</u>, and only activate the app after clearing immigration. Only travellers aged 6 or below this year are exempted from installing TraceTogether.

If you encounter issues activating TraceTogether:

- a. Submit a request for assistance to <a href="mailto:support@tracetogether.gov.sg">support@tracetogether.gov.sg</a>; OR
- b. <u>Collect a TraceTogether token after arrival for a one-time fee of S\$13</u>

### ☐ Step 5: Immigration Clearance in Singapore

Follow the instructions of officers and signages on arrival for the appropriate clearance lanes.

Travellers who were not vaccinated in Singapore will have their temporary vaccination status of 30 days reflected in their TraceTogether app shortly after clearing immigration. Those who do not have their vaccination status accurately reflected can write in via this form .

For foreign visitors, an <u>e-Pass (i.e. Visit Pass)</u> stating the period of stay granted will be issued via the email address indicated in SGAC. Passports will no longer be stamped.

If you are symptomatic on arrival, you may be directed to take a COVID-19 test or other requirements as instructed by officers. Each Antigen Rapid Test (ART) administered will cost S\$30, while each COVID-19 Polymerase Chain Reaction Test (PCR Test) will cost S\$138.

# ☐ Step 6: Comply with Local Health Protocols

Comply with the latest public health measures, including the use of the TraceTogether app to show proof of vaccination in settings where Vaccination-Differentiated Safe Management Measures (VDS) apply. Visit the <u>Ministry of Health website</u> for the latest public health measures. If you test positive for COVID-19 during your stay, adhere to these <u>recovery protocols</u>.

**Travellers who were vaccinated overseas** must register their vaccination status into the Singapore National Immunisation Registry (NIR), if you are any of the following traveller types and have not previously registered before.

Traveller Type	When must registration be done
Worker in Construction, Marine Shipyard or Process Sector (CMP worker) on Work Permit, Training Work Permit, S-Pass or In-Principle Approval of these 3 passes	Within 7 days of arrival
Staying in Singapore for more than 30 days (including all Long- Term Pass Holders not mentioned above)	Within 30 days of arrival

Registration can be done at any <u>Public Health Preparedness Clinic</u>. Confirm if your chosen clinic can facilitate the registration before heading down with the following documents:

- a. Personal identification documents
- b. Valid vaccination certificate (see <u>Step 1</u> for details).

You may also need to take additional COVID-19 vaccination doses to maintain good protection and continue to qualify for Vaccination-Differentiated Measures in Singapore. This is determined based on the date of the last dose of your primary vaccination series and the vaccine type you have taken (summary in table below). Vaccine Type	When additional dose is recommended to maintain good protection against COVID-19	When you will lose your vaccinated status for Vaccination-Differentiated Measures
Sinovac/Sinopharm vaccines	Third dose: Around 3 months from your second dose  Booster dose: Around 3 Months from your third dose	120 days after your second dose if you have not taken a third dose  270 days from your third dose if you have not taken a booster
All other WHO-EUL vaccines (excluding Sinovac/Sinopharm)	Booster dose: Around 5 months from the last dose of your primary series	270 days from the last dose of your primary series if you have not taken a booster
