## Checklist for Fully Vaccinated Travellers

---

### **Instructions before use:**

This checklist is for **all modes of arrival to Singapore via air, land or sea.**

This travel checklist is for **all travellers, including Singapore Citizens or Permanent Residents**, who are:

- Fully vaccinated against COVID-19; OR
- Aged 12 and below (i.e. born in or after 2010) and not fully vaccinated

If you do not meet the above criteria or are not sure on the definition of “fully vaccinated”, return to the [“Travelling to Singapore”](#) page to determine the entry requirements most relevant to you. Travellers transiting in Singapore to another destination without clearing immigration should refer to the [“Transiting through Singapore”](#) page for information.

Readers referencing this checklist can indicate “” in the boxes () for any completed activities.

### Stage 1: Pre-Departure for Singapore

#### **A) Ensure Vaccination Documentation is in Order**

If you **have** a [recognised Digitally Verifiable Vaccination Certificate \(DVC\)](#), use the [Vaccination Check Portal \(VCP\)](#) to verify that your DVC is recognised by the Singapore authorities. The VCP will issue a vaccination acceptance letter if the verification is successful, which you can use for boarding and immigration checks. If you are unable to get your DVC verified, troubleshoot your submission with the [vaccination certificate FAQ](#). If still faced with uploading issues, refer to the instructions below for travellers with non-DVCs.

If you **do not have** a recognised DVC, or have had difficulties verifying your DVC on the VCP, prepare a Vaccination Certificate (including certificate on a vaccination app) that is in English, or accompanied with notarised English Translation, with the following details:

1. Name (per travel document used for entry)
2. At least one other personal identifier, e.g. date of birth or passport number (per travel document used for entry)
3. Country of vaccination
4. Name of vaccine(s) administered, i.e. different names for different vaccine type
5. Vaccination date(s)

**B) Obtain Approvals and Prepare Travel-Related Documents**

Prepare the travel documents below, if required, and visitors should ensure that their passport is **valid for at least 6 months**. Entries for non-Citizens or Permanent Residents can be denied if the required documents are not produced during pre-boarding or immigration clearance.

**C) SG Arrival Card with electronic Health Declaration**

All travellers including Singapore Citizens and PRs must complete the [SG Arrival Card \(SGAC\)](#) with electronic Health declaration **within 3 days before arrival to Singapore**. You are encouraged to **complete the declaration before departure** as upon submission of your SGAC declaration, you will receive an email acknowledgement which you can present for smoother pre-boarding and immigration checks. **Travellers who travel frequently to Singapore must submit the SGAC for each trip to Singapore (e.g. if travelling to Singapore on 1,2 and 3 March, 3 separate submissions must be made, 1 for each arrival).**

Defer your travels if you have experienced the onset of any COVID-19 symptoms in the last 7 days before departure. This may include fever, cough, runny nose, sore throat, loss of taste or smell.

**D) COVID-19 Pre-Departure Test (PDT)**

A Pre-Departure Test (PDT) is only **not** required if you:

- a. Are entering Singapore via Land; **OR**
- b. Tested positive for COVID-19 **between 7 to 90 days** before your date of departure for Singapore - use [this tool](#) to check if the pre-departure test can be waived, and the documentation required to prove recovery.

Otherwise, if you are arriving by air/sea, and born before 2020 (i.e. above 2 years old), take any of the following COVID-19 tests within 2 days before departure:

- a. COVID-19 Polymerase Chain Reaction test (PCR test) at an [internationally accredited or recognised lab/clinic/medical facility](#) ; **OR**
- b. Antigen Rapid Test (ART) that is:
  - a. Administered by a trained professional; **OR**
  - b. **[Singapore Citizens, PRs and Long-Term Pass Holders (including In-Principle Approval holders) only]** Self-administered Antigen Rapid Test (ART) remotely supervised by an [approved ART provider in Singapore](#)

Ask for a non-handwritten PDT report that is in English (or accompanied with a notarised English Translation) containing the following details:

- i. Traveller's name, and Date of Birth or Passport number (per the passport used to travel to Singapore); and
- ii. Reflects the date and result of the COVID-19 test.

**When Should I take my PDT:**

## When Should I take my PDT:

- i. **Direct Journey to Singapore:** Traveller A is scheduled to depart for Singapore on 3 Nov 2022, 2359h. The earliest he can take his PDT is on 1 Nov 2022, 0001h.
- ii. **Less than 24-hour stay at transit location before arrival in Singapore:** Traveller B is scheduled for departure on 3 Nov 2022 from Airport A. He will transit at Airport B for a period lasting less than 24 hours. The earliest he should take his PDT is on 1 Nov 2022, before his departure from Airport A.
- iii. **More than 24-hour stay at transit location before arrival in Singapore:** Traveller C is scheduled for departure from Airport A on 3 Nov 2022. He will transit in Airport B for a period lasting more than 24 hours. In this scenario, he will take his PDT at Airport B, within 2 days before his connecting flight to Singapore.

### E) Install and Activate TraceTogether

If you are a visitor and do not already have the [TraceTogether contact tracing mobile application](#) , install it using [this guide](#) , and only activate the app after clearing immigration. Only travellers aged 6 or below this year are exempted from installing TraceTogether.

If you encounter issues activating TraceTogether:

## Stage 2: Departure for Singapore

### Pre-boarding Document Checks

Transport operators may ask for documents listed at Stage 1 during pre-boarding checks. Failing which, you may be denied boarding.

## Stage 3: Immigration Clearance in Singapore

### Immigration Clearance

Follow the instructions of officers and signages on arrival for the appropriate clearance lanes.

Upon clearance, an [e-Pass \(i.e. Visit Pass\)](#) stating the period of stay granted will be issued to foreign visitors via the email address indicated in SGAC. Passports will no longer be stamped.

If you are symptomatic on arrival, you may be directed to take a COVID-19 test or be subjected to other requirements as instructed by officers. Each Antigen Rapid Test (ART) administered will cost S\$30, while each COVID-19 Polymerase Chain Reaction Test (PCR Test) will cost S\$138.

## Stage 4: Health Protocols during Stay in Singapore

### A) COVID-19 Safe Management Measures and Proof of Vaccination

Comply with the latest public health measures, including the use of the TraceTogether app to show proof of vaccination in settings where [Vaccination-differentiated Safe Management Measures \(VDS\)](#) apply.

If you are vaccinated overseas, a temporary vaccination status which is valid for 30 days will be reflected on the [HealthHub](#) or [TraceTogether](#) mobile application. If your vaccination status has not been reflected correctly within a few hours after arrival, write in using [this form](#) for assistance.

### B) Register Overseas Vaccination Record and Take COVID-19 Boosters

**Travellers who were vaccinated overseas** must register their vaccination status into the Singapore National Immunisation Registry (NIR), if you are any of the following traveller types and have not previously registered before.

Traveller Type	When must registration be done
Worker in Construction, Marine Shipyard or Process Sector (CMP worker) on Work Permit, Training Work Permit, S-Pass or In-Principle Approval of these 3 passes	<b>Within 7 days of arrival</b>
Staying in Singapore for more than 30 days (including all Long-Term Pass Holders not mentioned above)	<b>Within 30 days of arrival</b>

Registration can be done at any [Public Health Preparedness Clinic](#). Confirm if your chosen clinic can facilitate the registration before heading down with the following documents:

- i. Personal identification documents
- ii. Valid vaccination certificate (see [Stage 1A](#) for details).

You may also need to take additional COVID-19 vaccination doses to maintain good protection and continue to qualify for Vaccination-Differentiated Measures in Singapore. This is determined based on the date of the last dose of your primary vaccination series and the vaccine type you have taken (summary in table below). Vaccine Type	When an additional dose is recommended to maintain good protection against COVID-19	When you will lose your vaccinated status for Vaccination-Differentiated Measures
Sinovac/Sinopharm vaccines	Third dose: Around 3 months from your second dose  Booster dose: Around 3 Months from your third dose	120 days after your second dose if you have not taken a third dose  270 days from your third dose if you have not taken a booster
All other WHO-EUL vaccines (excluding Sinovac/Sinopharm)	Booster dose: Around 5 months from the last dose of your primary series	270 days from the last dose of your primary series if you have not taken a booster

**C) Contracting and Recovering from COVID-19**

If you test positive for COVID-19 during your stay, [adhere to these recovery protocols.](#)
